- Must be able to clearly explain and demonstrate step by step product usage and cover all relevant theoretical information
- Must be able to relate all information to various levels of educated stylists

EXPERIENCE:

- Applicant should be a working stylist with at least 3 years experience
- Applicant should have attended a variety of advanced training programs
- Should have experience in conducting educational classes for a manufacturer or distributor.

If applicant has not had the above experience, they must project ability to perform in this capacity

- Must have a strong desire for advancement through education and teaching educational classes
